The Anderson County Dust Control Program consists of the application of liquid magnesium chloride to gravel roads in the County. Dust Control Programs are not required in the State of Kansas and Anderson County offers this service to the County residents in an effort to help abate the dust created by traffic. The application of dust control treatment will **not** eliminate dust. The effectiveness and duration of the dust control treatment is dependent on traffic volumes, weather, thickness of gravel, drainage, etc.

This is the only dust control program offered or recognized by the County. The County does not warrant the product in any way and the applicant agrees to hold Anderson County harmless for the failure of this product to control dust; this service will be provided by an independent contractor.

The deadline to apply for this program is April 9, 2025 @ 12:00 PM. Applications received after this date will be returned and not included in this year's program. Office hours are Mon – Fri 7:00 AM – 3:30 PM

A single treatment application will be used. The exact date of the treatment application will depend on weather conditions and product availability. Dust Control spots will be measured and flagged by Anderson County Road Department after the deadline of April 9, 2025.

The County will make every effort to not disturb the treated area during a period ending on October 1, 2025 **but reserves the right to maintain the road at any time it is determined necessary to provide a safe public roadway. Neither refund nor treatment will be made for shortened dust control treatment life resulting from required maintenance.** After that time, the County will resume normal maintenance operations. Maintenance activities on dust control areas, as with other parts of the county road system, will be solely at the discretion of the Road & Bridge Supervisor.
